Program Guidelines

- In order to qualify for this assistance, this application must be fully completed and submitted to admin@fbicc.com.
- You must provide backup documentation, or explanation for why documentation cannot be obtained as requested
- The source of the funds for this program are from Quarterly FBICC General Assistance Program.
- Enrolled tribal members 18 years and older that have had General Assistance deposited into the Youth Account may apply.
 - The applicant will be required to meet with the Tribal Council to receive payment.
 - The applicant will be required to meet with TallSalt for Financial Education.
- Applications with special circumstances will be required to meet with the Tribal Council for a final decision.
- The Tribal Council will approve applications and payout amounts at a regularly scheduled meeting council meeting in a closed session to protect recipients' privacy
- The Fort Bidwell Tribe's accounting and finance staff will track the number of applications processed, funds disbursed, and funds remaining.

Eligibility Requirements

Applicants must be an enrolled member of the Fort Bidwell Indian Reservation.

Applicant must submit a fully completed application with necessary documentation or explanation.

Applicant must provide additional documentation or explanation as requested.

Applicants are responsible for providing accurate information as required in the application form.

Applicant Rights

Applicants shall receive an application when requested.

Applicants shall have protection and privacy of personal information which is only to be used for verification and eligibility purposes.

Applicants with complete applications shall receive funds in a timely manner.
